## FEP Pressure Sensitive Adhesive Tape

**CHR C** and 2355-2 are manufactured from clear FEP (fluorinated ethylene propylene) film with pressure-sensitive, high-temperature silicone adhesive.

### Features/Benefits

Both **CHR C** and 2355-2 tapes are very durable and versatile products. The FEP backing offers excellent high temperature resistance and they offer the highest electrical strength in volts per mm. FEP backing is chemically inert, thin and conformable. The tape construction is weather resistant, stable and non-toxic.

### Availability

Factory stock for both tapes is in master log form 33 m x 635 mm (36 yd x 25 in) wide. Rolls can be slit 12.7 mm to 635 mm (0.5 in to 25 in) wide. Slit rolls under 12.7 mm (0.5 in) wide are available in 16.5 m (18 yd) long rolls only. They are available with or without a liner.

### Applications

**CHR C** and 2355-2 tapes are often used for coil and transformer insulation. Due to its transparency, these tapes are useful for “see through” identification on wire harnesses.
